

# Invitation to Show

The Waimea Arts Council cordially invites you to participate in the  
**21<sup>ST</sup> ANNUAL HELEN M. CASSIDY MEMORIAL JURIED ART SHOW**  
at the Firehouse Gallery during the month of October.

This event is by invitation only. Categories are: (1) oil, (2) acrylic, (3) watercolor; (4) colored pencil/pastel, (5) pen and ink/pencil/charcoal; (6) photography; (7) glass/ceramics/sculpture; (8) mixed media; and (9) other (baskets, fabrics, computer, jewelry, etc.). If there are not enough entries in each category, it will be the judge's discretion to combine categories.

Artists are invited to submit one entry per category for a total of two entries; finished size no greater than 36" x 36". All work must be original and must not have been submitted for a previous Cassidy Show or won previous awards in any art competition. Unframed work or those requiring two people to move are unacceptable. NFS pieces will not be eligible for prizes. There is a non-refundable entry fee of \$10 per person. Entrants must be paid up current (2005/2006 – fiscal year begins October 1<sup>st</sup>.) members of the Waimea Arts Council.

Artwork, ready for hanging, must be submitted beginning at 10:00 a.m., September 28<sup>th</sup> and no entries will be accepted after 2:00 p.m., Saturday, October 1<sup>st</sup>. Judging for prizes will be on Sunday, October 2<sup>nd</sup>. Entries will be evaluated within each category using five criteria: originality, visual balance, visual clarity, personal expression and execution of the medium. Those selected by the judges will be hung in the Firehouse Gallery throughout the month of October. Ribbons and cash prizes will be awarded for 1<sup>st</sup> and 2<sup>nd</sup> place in each category.

Reception and Awards Presentation combined with Waimea Arts Council's 30<sup>th</sup> Anniversary, post-construction Open House, and announcements of elected board members, to be held on Saturday, October 8<sup>th</sup>, 3:00 – 5:00 p.m.

Artists will be responsible for liability of individual art and will hold the Waimea Arts Council and the County of Hawaii harmless. Artists selling their exhibited works are requested to make a 20% donation to the Waimea Arts Council. Artists are asked to sign up to sit the Gallery during hours the gallery is open (10:00 a.m. - 2:00 p.m. Tuesday through Saturday).

The show will close on Saturday, October 29<sup>th</sup>. Artists are asked to pick up pieces on that date between the hours of 10:00 a.m. and 2:00 p.m., or call to arrange a later pick up date.
