PROSPECTUS

This event offers fiber artists a unique opportunity to exhibit (and to sell) their functional and decorative art. The show is hosted by the Waimea Arts Council and will be held at the organization's historic Firehouse Gallery, located in the heart of upcountry Waimea at the intersections of Hwys. 19 & 190.

Eligibility

Participation is open to all Big Island artists 18 years of age and older. Work created in any fiber media and/or using fiber techniques is eligible for inclusion. Pieces must contain at least a 75% fiber content. The exhibiting artist must comply with all the terms and conditions laid out below. The gallery reserves the right at any time to modify these terms and conditions. The gallery committee has final say as to what will be exhibited in the show.

Guidelines

No entry fees, however monetary donations to help support this event are appreciated and tax deductible.

- No more than three entries per artist.
- No entries from kits will be accepted. All work must be originals created by the artist.
- Maximum size 160 square inches (example 40 x 40").
- The fiber component of the work must be a minimum of 75%.
- Works must have been created after January 2000.
- Artwork must be presentation ready. Bring your own hanger for wall hangings. Framed work must be wired. Pedestals are available for sculptural pieces.
- Exhibiting artists are required to volunteer 6 hours during gallery hours.
If you are not a recently trained docent you will assist someone who is trained.

Gallery Sales & Commission

All items must be for sale. There will be a 25% commission for current and new WAC members works sold, a 50% commission on non-member works sold. No pieces may be removed before the end of the exhibition. No commercially made pieces from kits. Beware of copyright laws especially with purchased quilt patterns.

The Waimea Arts Council and Firehouse Gallery will exercise due care in handling work submitted for this exhibit. Waimea Arts Council and/or Hawaii County or their agents will not be responsible for loss or damage to any work submitted. Work exhibited in the gallery is not covered against theft.

Saturday, June 28 from 11 am - 3 pm and Sunday June 29, 9 am - 3 pm. Pieces not picked up will be considered a donation to the Waimea Arts Council.
