In addition to the above benefits, WAC Participating Artist Members are eligible to participate in all Firehouse Gallery Exhibits subject to guidelines set forth by the Gallery Committee. You can earn the right to reduce the donation amount to \$25 by fulfilling the volunteer obligation. In addition, you will be eligible to have small solo shows in the back gallery on a rotating basis, and may be included in our Gallery of Artists display (no charge) and on our website (\$25 one-time fee). As a participating artist you are expected to contribute your time and talent to the welfare of WAC and the Firehouse Gallery, as a gallery docent or other volunteer position for at least 4 hours per month.

Guidelines and Waiver for Artists Exhibiting at the Firehouse Gallery

In submitting work for display at Waimea Arts Council's (WAC) Firehouse Gallery I agree to the following conditions:

- The Gallery Committee has the right to choose work for display based on appropriateness of content, presentation, and space available. No nudes may be exhibited in the gallery.
- Art must be delivered to the gallery at the times/date specified and picked up by the artist no later than one week following the close of the exhibit. Work left at the gallery after that time will become the property of the WAC and will be disposed of at the discretion of the WAC Board, unless special arrangements are made with the Gallery Curator.
- I understand that the WAC is not responsible for paying General Excise Tax on artwork sold for the artist at the Firehouse Gallery. It is my responsibility to hold a GET license, to keep track of my sales, and to submit the tax as required by state law.

WAIVER

All artwork delivered to the Firehouse Gallery will be handled with the utmost of care. However, the Waimea Arts Gallery will not be held responsible for damage, theft, or loss of work exhibited and WAC insurance does not cover items belonging to individual artists while the items are in our gallery. Each artist is responsible for obtaining their own personal insurance to cover artwork - to include paintings, prints, cards, jewelry, three dimensional art, or any other item left at the gallery to be put on exhibit, and/or for sale and also to include events outside of the WAC building held under the auspices of the Waimea Arts Council.

I understand the terms of the exhibition and agree to be responsible for the liability of individual art. I also agree to indemnify and hold harmless the Waimea Arts Council, its employees and volunteers, and the County of Hawaii from any and all claims relating to damage or loss of my property in or about the Waimea Arts Center, and from any court costs and attorney fees relating thereto.

Submission of artwork implies acceptance of all the conditions listed above.
