## ~ PROSPECTUS ~

## WHO

This juried art show is open to current and new members (October 2022- September 2023) of the Waimea Arts Council. Basic membership (\$35 annually) is open to all adults 18 and older. All media will be accepted: \$300 First Prize Award. Other cash awards announced Oct. 1, 2022.

## **ENTRIES**

Entry fee is \$15 **per** entry. You may enter as many pieces as you wish. **Entry fees are non-refundable**. All entered pieces must be available for sale. Works must be original (no prints or reproductions will be accepted, with the exception of photographs), have been completed in the last two years and have not been accepted in past Waimea Arts Council sponsored juried shows or have won previous awards in any contest.

The maximum size for any entry, including frame is 36" x 36" (or an equivalent of 1296 square inches). Artwork must be ready for installation - including suitable frames with wires (no saw tooth hangers or shrink wrap), bases and/or mounts as required.

Artists' sale price should factor in a donation/commission to the Waimea Arts Council (501(c)3 nonprofit organization). For those who volunteer during the show, a 30% donation/commission will go to the WAC. If at the "Participating Artist of Waimea Arts Council" membership level, the commission percentage will be calculated by the number of volunteer hours. The donation/commission to WAC is 50% for those who do not volunteer.

All exhibitors are asked to volunteer to keep the gallery open during the show.

### JUDGING

This is a juried show, and the juror has discretion to choose which entries will be included in the exhibit. Entry fees will not be refunded if a piece is not chosen for exhibit. Entries will be judged using five criteria: originality, visual balance, visual clarity, personal expression and execution of the medium.

Our judges are all exceptional artists with a depth of understanding of the culture of our Island. Kanaka Maoli Moses Kealamakia is an award-winning artist and teacher who has recently returned to his birthplace, Waimea. Mary Spears' artwork has been featured in numerous shows throughout Hawaii; she is an active art instructor whose design work encompasses logo creation to fabric . Smart Shark Designs Gallery owner and artist Martin Sanchez has been described as animated, quirky and bold like his paintings, bringing a colorful perspective to the judging table.

First Place will be awarded \$300. Cash award amounts for other prizes will depend on the number of entries.

## ENTRY DATE

Works must be submitted at the Firehouse Gallery, 67-1201 Mamalahoa Hwy., between the hours of 11 am to 3 pm on Saturday & Sunday, September 24 & 25. Those artists whose pieces are not chosen for exhibition will be contacted to pick the artwork up.

Exhibiting artists are asked to volunteer to keep the gallery open (minimally) for four hours during advertised galley hours. (Gallery hours: 11 am – 3 pm Friday through Sunday).

### RECEPTION

A Public Reception will be held on October 1 from 2:00-5:00. Our Jurors, artists and the public will be invited.

## PICK UP DATE

Those works selected will be on display for viewing and purchase in the Firehouse Gallery October 1 - November 28, 2021. You may pick up your pieces in the afternoon of November 28. Pieces left after 30 days will be considered abandoned and may become the property of WAC and considered as a donation.

The Waimea Arts Council will handle all work with the utmost of care; however, artists will be responsible for liability of individual art and will hold the Waimea Arts Council and the County of Hawaii harmless. WAC reserves the right to cancel the show if there are not enough entries.

Individual artists who join the Waimea Arts Council may enter the show. A membership form is attached as part of this prospectus.

## General Guidelines and Waiver for Members Exhibiting in the Firehouse Gallery Programs

In submitting work for display at the Waimea Arts Council's (WAC) Firehouse Gallery, I agree to the following conditions:

- The Gallery Committee has the right to choose work for display based on appropriateness of content, presentation, and space available. No nudes may be exhibited in the gallery.
- Art must be delivered to the gallery at the times/date specified and picked up by the artist no later than one week following the close of the exhibit. Work left at the gallery after that time will become the property of WAC and will be disposed of at the discretion of the WAC Board, unless special arrangements are made with the Gallery Chair.
- I understand that WAC is not responsible for paying General Excise Tax on artwork sold for the artist at the Firehouse Gallery. It is my responsibility to hold a GET license, to keep track of my sales, and to submit the tax as required by state law.

### WAIVER

All artwork delivered to the Firehouse Gallery will be handled with the utmost of care. However, the Waimea Arts Council will not be held responsible for damage, theft, or loss of work exhibited. Each artist is responsible for obtaining their own personal insurance if they choose to cover artwork and or any other item left at the gallery. This includes events held outside of the gallery and under the auspices of the Waimea Arts Council.
