# Waimea Arts Council Logo Contest Rules Submissions Due September 23, 2023

The Waimea Arts Council (WAC) is a nonprofit organization dedicated to promoting the arts, the encouragement of artists, and providing a forum for art-related community events.

To bring awareness to the 50th Anniversary starting this October, and to launch this art organization into the future with increased community involvement, the year's celebration begins with a logo contest.

The new WAC logo could be two separate designs: one to include the words Waimea Arts Council, and the other 50th Anniversary, yet it is important for the contestants to make them both work together for the year's needs in all written materials. The logo design will be used for all visual correspondence including printed materials, social media and internet uses.

## Logo Contest Guidelines

- 1. No entry fee, ages 16 and up eligible, must be Hawaii resident.
- 2. Logo to include text: Waimea Arts Council, 50th Anniversary.
- 3. Entries must be submitted as JPEG files in a minimum 300 dpi format. For quality reproduction purposes, the winning entry person must later submit it in scalable vector graphic format (EPS). Color must be CMYK. The logo need also be submitted in black and white.
- 4. The logo must be easy to use, handle, resize, and manipulate for all reproduction purposes. It should be visually appealing on both small (1.5" x 1.5") and large scales, and be clearly readable in black and white.
- 5. One or more submissions per person is acceptable. Each submission must be sent in a separate email.
- 6. All entries will be submitted electronically to <a href="mailto:submissions@waimeaartscouncil.org">submissions must</a> include the full name(s) of the person(s) who designed the logo, name, email address, postal address, and telephone number. A return email will be sent confirming submission within two days upon receipt.

### Intellectual Property

- 1. Entrants affirm their submissions are their own original work, have not been copied from others or previous designs, including their own, and do not violate the intellectual property rights of other persons or entities.
- 2. Submissions become the sole property of WAC and may be used for any WAC purposes. WAC shall have the right to adapt, edit, modify, or otherwise use the winning submission in part or in its entirety in whatever manner it deems appropriate.

#### Determination of Winner and Prize

- 1. The winning entry will be selected by a 3-5 person panel composed of selected members of WAC. Their decision will be final. An email will be sent September 29 to all submission emails with results.
- 2. The prize for the winning entry remains the same regardless of the team size submitting the winning entry.
- 3. The winner will be notified via email and announced on the WAC website, Facebook and Instagram pages.
- 4. Winner selected receives \$200.00 and one free year \$70.00 participating artist membership, plus in-kind donation receipt provided on request.
